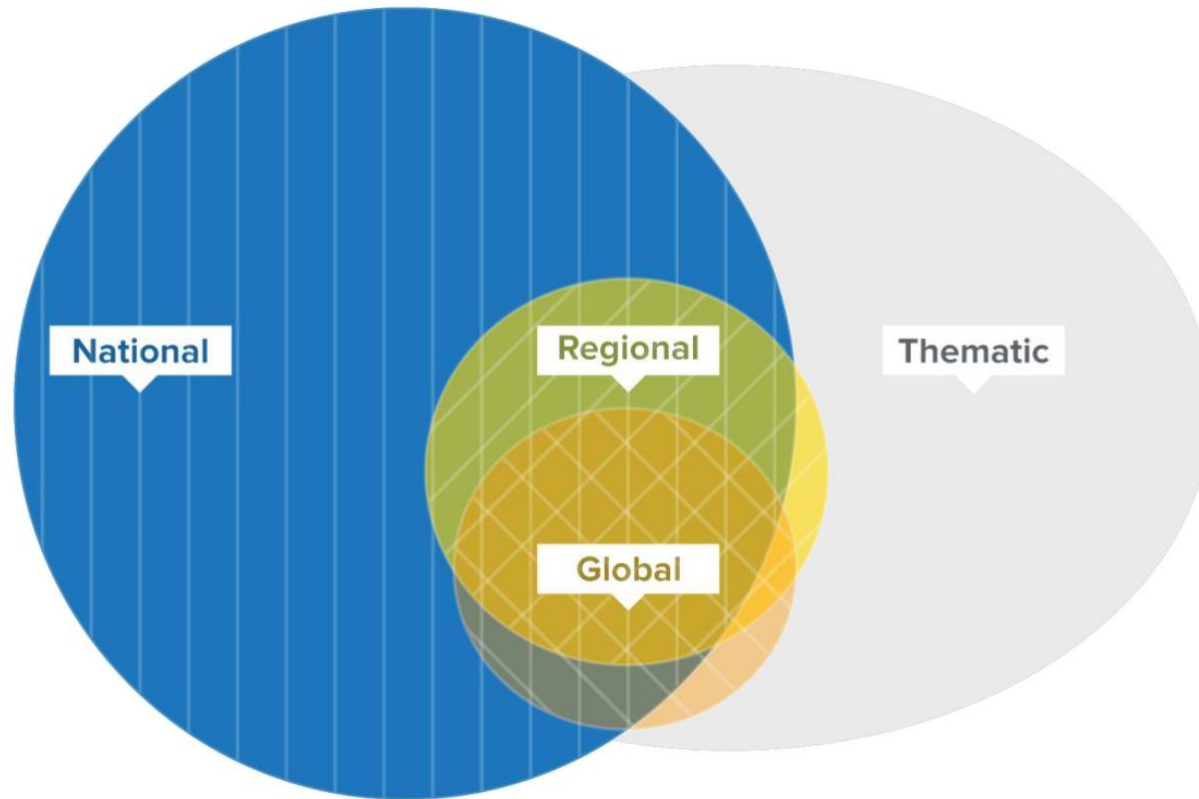

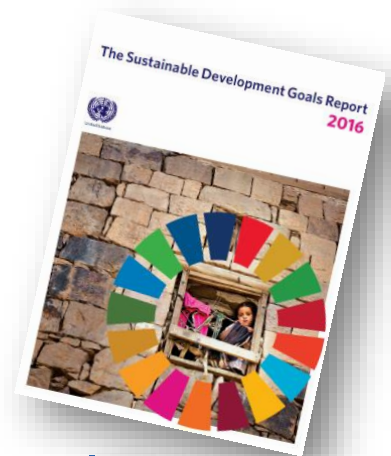

# First reports produced in 2016

## Global level:

2016 SDG report, produced by UN system, showing 50 out of 241 global SDG indicators



## EU level:

Ad hoc Eurostat publication on SDGs in EU context, showing 51 indicators selected ad hoc



## National level:

Reporting on national SD strategies based on national SD indicator sets

# Set of global SDG indicators

## ***244 SDG indicators for global monitoring***

approved by 48th UNSC in New York on 10 March 2017  
*(231 separate indicators as 10 appear more than once)*

Tier classification for data availability and  
methodological development:

- **Tier 1: Data regularly produced (84 / 35%)**
- **Tier 2: Methodology exists but no data (65 / 27%)**
- **Tier 3: No international methodology exists (86 / 36%)**

# Eurostat's role in global monitoring

- Member of IAEG-SDGs sub-groups on SDMX (data exchange) and geospatial information
- Support custodian agencies in developing tier 3 indicators in our fields of competence
- Eurostat has no plan to be an EU data hub for global SDG reporting
- Eurostat's does not intend to enlarge current ESS surveys *exclusively* in order to fill data gaps on particular global SDG indicators.

# Background – 2016 Communication

Communication COM(2016) 739 on [Next steps for a sustainable European future](#), released on 22 Nov. Page 16:

*A first overview of where the EU and its Member States stand in view of the SDGs can be found in the **Eurostat publication** issued in parallel with this Communication. From 2017 onwards, the Commission will carry out more detailed regular monitoring of the Sustainable Development Goals in an EU context, developing a reference indicator framework for this purpose ...*



# Setting up an indicator set for regular EU SDG monitoring

- Eurostat in the lead within the Commission
- In cooperation with other Commission services (DGs) and Member States experts
- Strong links with Communication and long-term EU policies: Europe 2020, 10 Commission Priorities, Circular Economy etc.
- Structured along the 17 SDGs and aligned as far as appropriate with the UN list of global indicators

# The EU SDG indicator set

- EU SDG indicator set of **less than 100** «**ready to use**» **indicators** (no placeholders)
- Use of «**multipurpose indicators**» to broaden the number of indicators for monitoring per goal
- Preference given to «ESS indicators». Non-ESS indicators provided they satisfy **minimum quality requirements**

# Indicator selection: a 3-step approach

- Assessment of **policy relevance**
- Check against **admissibility criteria** (based on the **Code of Practice of European statistics**)
- **Quality rating** (based on ESMS, the ESS quality framework)

This approach **maximises relevance and quality** of the overall indicator set.

## Example: Pre-final draft of indicator selection for goal 11 (1)

- Share of total population living in a dwelling with a leaking roof, damp walls, floors or foundation, or rot in window frames or floor
- Overcrowding rate *by degree of urbanisation* - total population
- Distribution of population by level of difficulty in accessing public transport → *SILC data; geospatial data as alternative source?*
- People killed in road accidents
- Urban population exposure to air pollution by particulate matter (micrograms per cubic metre)
- Proportion of population living in households considering that they suffer from noise  
→ *SILC data; geospatial data as alternative source?*

## Example: Pre-final draft of indicator selection for goal 11 (2)

### *Multipurpose indicators (MPI) from other SDGs*

- Housing cost overburden
- Population connected to urban wastewater treatment with at least secondary treatment
- Modal split of passenger & freight transport
- Recycling rate of municipal waste
- Artificial land cover per capita  
→ *Land cover data based on LUCAS survey or Copernicus?*
- Share of population which reported occurrence of crime, violence or vandalism in their area

- **10 Apr**      **Final draft of EU SDG indicator set**
- **End Apr/early May: Approval of EU SDG indicator set**

→ EU SDG indicator set stays **open to future changes**  
(new data developments, review of EU policies such as Europe 2020)
