

GISCO team – Role and main tasks




Permanent service of the European Commission (Eurostat)

- Collect, validate and provide reference geographical information and related services for use within Eurostat, the European Commission, and to the European citizens at large
 - ✓ Infrastructure and tools, relevant geospatial data
- Answer the needs of the European Commission, Eurostat and to some extent of the Member States for geographical information at the level of the European Union, its Member States and regions
 - ✓ Specialized resources, guidance and training, thematic mapping/data and spatial analysis
- Contribute to, and coordinate, the work in the European Statistical System on the integration of statistical and geospatial information

- EG-ISGI (Expert Group on the Integration of Statistical and Geospatial Information)
 - Developed the Global Statistical Geospatial Framework (GSGF) to facilitate the integration of statistical and geospatial information
